### ORDER

The Head, Computer Science, vide the letter read as (1) above, has forwarded the proposal submitted by Professor (Dr.) G Santhosh Kumar, Department of Computer Science for starting a Five Year Integrated M.Sc.in Computer Science with Specialization in Data Science and Artificial Intelligence.

Vide paper read as (6) above, the Course Structure and Regulation of this Five Year Integrated M.Sc in Computer Science (Artificial Intelligence & Data Science) to be offered at the Department of Computer Science under the Faculty of Technology, with effect from 2021-22 admissions was approved.

Having considered the request, and based on the above, the Vice Chancellor, has accorded sanction for the following, subject to ratification by the Syndicate.

1. To start the 5 Year Integrated M.Sc.in Computer Science (Artificial Intelligence & Data Science) under the Faculty of Technology, offered at the Department of Computer Science, with effect from 2021-22 admission onwards with the following criteria:-

(i) **Eligibility Criteria :**

(a) Candidates with a minimum of 75% marks at +2 level of education (Intermediate, CBSE/ICSE/HSC/ All State Boards or Equivalent) with Science subjects, Physics, Chemistry, and Mathematics are eligible to apply.

(b) Candidates possessing the KVPY Scholarship will be directly admitted to the programme if they have the required eligibility given above. Such candidates need not have to appear for the

Common Admission Test (CAT) . But they have to submit the requisite application and should pay the application fee. All other eligible candidates will be called to appear for a Common Admission Test (CAT) to be held at various centres. After the entrance examination results are published, the admission will be made through a common counseling process.

**(ii) Intake and semesters:**

The present intake for the M.Sc (5-Year Integrated) Programme in Artificial Intelligence is 20. The total number of semesters for the programme will be ten. The programme being a Post Graduate programme with specialization, there will not be an exit option after six semesters.

(iii) The 5 year Integrated M.Sc in Computer Science (Artificial Intelligence & Data Science) course is regular. The fees structure of 5 Year Integrated M.Sc. in Computer Science (Artificial Intelligence & Data Science) is as given below:
